Middle Road Bridge: Updated cost of project from \$209,000 to \$261,000.

Middle Road Culverts: A public meeting was held on October 7, 2021, minutes are available.

New Business:

Unpaid Bills Due to Town: Discussed unpaid culvert bills to town. No action taken.
