ROAD REPORT

Dusty Huestis gave the road report, stating that paving of East, Market, Short and apron of Lovers Lane is complete. Street lines to be painted by end of month and road cracks to be sealed soon. The road crew has put in 9 culverts this year with more big ones to go in. Sunderland/Crown Point Road bridge will be completed this summer.

A motion was made by Matt Lawton and seconded by David Bronson to apply for a grant-in-aid from ACRPC for \$11,300 with Town paying a 20% match. Motion passed.

CULVERT COMNMITTEE REPORT

Joan Huestis brought first bill from DuBois & King. Motion made by Tim Howlett and seconded by David Bronson to approve and pay the bill. Motion passed. Otter Creek Engineering will most likely be the design consultant on the project.

OTHER BUSINESS

Driveway Access permit will be revised in a simple clear format as the VLCT model is too complex for our Town.

Porta-Potty for Champlainside Drive was suggested.
